Economic Impact Analysis for the Valhalla Wind Project

Nova Clean Energy is developing the Valhalla Wind Project in Big Stone County and Stevens County, Minnesota. The Valhalla Wind Project consists of an estimated 200-250 megawatts ("MW") in Big Stone County and 50 MW in Stevens County of capacity of wind turbines and the associated access roads, transmission and communication equipment, storage areas, and control facilities. The total Project represents an investment of more than \$450 million. The total development is anticipated to result in the following:


